






PROCESS

- 1. VERIFICATION: To meet the bank's Know Your Customer requirements, Customers can verify themselves by inserting a valid account card in the card reader or entering their account details via touchscreen or keypad.
- 2. CHANGE ORDER: Customers build their change order by selecting quantities and denominations on-screen. Then, they pay in banknotes for their change order. In online deployments, the total amount could also be charged directly to their account, working similarly to a business-dedicated ATM.
- **DISPENSE**: The BCi-8 dispenses rolled coins and notes by denomination, plus any change in loose coins if required.
- 4. ACKNOWLEDGEMENT: The solution prints a unique receipt, including branch details, account ID, timestamp and a breakdown of the cash dispensed by denomination.
